Review your copy of the citation for the Ordinance number that you have been charged with. That Chapter number should correspond with a specific Fine amount. Partial payments will not be accepted.

If the "PERSONAL APPEARANCE REQUIRED" box is checked ☒ YES on the citation, you must appear in court. If the "PERSONAL APPEARANCE REQUIRED" box is checked ☒ NO on the citation, you may waive your appearance in court by paying out your citation in one of the following ways **PRIOR** to the scheduled court date, or you will be expected to be in court:

PAY ONLINE - Secure payments may now be made using a credit or debit card through Bridge Payment Services. More information can be found at <http://ohioticketpayments.com/Loveland>. Please note that a convenience fee will apply.

PAY IN PERSON - You may pay your citation MON-FRI 8am-4pm at the Loveland Mayor's Court Clerk's Office, located at the above address. For after-hours, a drop box and payment envelopes are located on the building by the front entrance. Please **sign the back** of your copy of the citation and submit it with your payment.

PAY BY MAIL - Make check or money order payable to 'City of Loveland' for the payout amount indicated on this sheet and mail to the above address. Please enclose your signed citation.

If the ☒ NO block is checked under **FINANCIAL RESPONSIBILITY PROOF SHOWN** on the citation, you must provide proof of financial responsibility to the Clerk of Court when payment is made or at your court appearance. Failure to do so may result in the suspension of your license by the Ohio BMV.

COURT COSTS: All court costs as permitted or mandated by the State of Ohio are assessed and are added to the fine and already included in the total amount due:

Moving Violations (Traffic Minor & Unclassified Misdemeanors; Pedestrian violation if cited as Driver): **\$52.00**

*Criminal/Misdemeanors: **\$42.00**

** Child Restraint, Pedestrian (Non-Driver) and Seatbelt: **\$23.00**

No additional costs are assessed for Parking Violations
