- Kroger had their final inspection for their protocol racks.
- The final inspection was done on the new pass through window at Cappy's.
- Two more units in Blossom Hill passed their final inspections, pending IBI's approval of all final electrical work. Once those approvals are issued, 130 and 132 Blossom View will receive their certificate of occupancies.
- The retaining wall work continues at 912 Loveland Madeira Rd, with another footer inspection scheduled for Friday.
- Inspections were completed on several ongoing residential projects within the city.
